PARTICIPANT'S AGREEMENT
FOR THOSE UNDER 18 YRS**

By signing this document you will waive certain legal rights, PLEASE READ CAREFULLY.

IN CONSIDERATION of allowing my minor child/ward to participate in the programs, activities and events of The Ontario Soccer Association, **I ASSURE TO YOU THAT:**

1. I am the parent/guardian of the above named participant having full legal responsibility for decisions regarding the above named participant.
2. I believe that my child/ward is physically, emotionally and mentally able to participate in the programs, activities and events of The Ontario Soccer Association.
3. I hereby acknowledge that I am aware of the risks and hazards associated with or related to soccer. The risks and hazards include, but are not limited to injuries from:
 - a. Executing strenuous and demanding physical techniques in soccer;
 - b. Dry land training including weights, running and massage;
 - c. Grass, turf and other surfaces including bacterial infections and rashes;
 - d. Falls to the ground due to uneven or irregular terrain or surfaces;
 - e. Collisions with walls and soccer equipment;
 - f. Failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment;
 - g. Extreme weather conditions which may result in heatstroke, sunstroke or hypothermia;
 - h. Contact, colliding or being struck by other participants, spectators, equipment or vehicles;
 - i. Vigorous physical exertion and strenuous cardiovascular workouts;
 - j. Exerting and stretching various muscle groups; and
 - k. Travel to and from competitive events and associated non-competitive events which are an integral part of the organization's activities.
4. Furthermore, I am aware that my child/ward may:
 - a. Sustain injuries in soccer that can be severe, cause spinal cord injuries and even be fatal;
 - b. Experience anxiety while challenging himself/herself during the activities, events and programs;
 - c. Come into close contact with other participants, including the possibility of accidental and unexpected contact;
 - d. Risk of injury is reduced if he/she follows all rules established for participation; and
 - e. Risk of injury increases as he/she become fatigued.

I UNDERSTAND AND AGREE, on behalf of myself, my heirs, assigns, personal representatives and next of kin that my signing of this document constitutes:

5. I am registering my child/ward willingly and my child/ward is participating voluntarily in these activities, events and programs.
6. I agree that there are risks in soccer as described above and my child/ward will be exposed to these risks and hazards.
7. I agree to accept all these risks and hazards and be responsible for any injury or other loss which my minor child/ward might receive while participating in these events, activities and programs.
8. If something happens to my child/ward, I release the Organizers of responsibility for any claims, demands, actions and costs which might arise out of my child/ward's participation. I understand "Organizers" to mean: The Ontario Soccer Association, District Associations, Leagues, Clubs and their directors, officers, members, employees, volunteers, officials, participants, clubs, agents, sponsors, owners/operators of facilities, and representatives.

CODES OF CONDUCT

The following Codes of Conduct are intended to codify acceptable behavior of good sportsmanship for all players and parents. They will continue to be reviewed and updated as we continue to evaluate our program. Any violation of these codes will be brought to the attention of the Corunna Wildcats Soccer Club's Policy and Administration Committee, which will issue the appropriate sanction. This sanction could include one or all of the following: 1) Reprimand 2) Probation 3) Suspension or 4) Expulsion.

Player Code of Conduct:

I pledge to accept responsibility for my Corunna Wildcats Soccer Club experience by following this Players' code of Conduct:

1. I will exhibit sportsmanship and fair play at every training session, competition and tournament. I will also encourage this behavior from other teammates, club-mates, coaches, officials and parents and supporters.
2. I will make every reasonable effort to attend all training sessions and competitions, and I will notify my coach if I cannot attend a training session or competition.
3. I understand that playing time in games is not guaranteed and is determined by my attendance, attitude and performance at practice sessions.
4. I will treat other players, coaches, officials and fans with respect regardless of race, sex, or ability, and I will expect to be treated accordingly.
5. I desire to play in an environment that is free of drugs, including tobacco and alcohol, and will expect others to refrain from their use at all training sessions and competitions.
6. I will encourage my parents to be involved with my team in some capacity because it is important to me.
7. I understand that I am representing the Corunna Wildcats Soccer Club. Poor behavior during practices, games or tournaments may result in lost playing time and expulsion from the team.
8. I will not engage in physical or verbal confrontations with players, coaches, officials or fans before, during or after training sessions and competitions.
9. I will refrain from the use of foul or offensive language.
10. I will maintain a good appearance at all times when representing the club.
11. I will come to training sessions and competitions ready to listen, watch and learn from my coaches.
12. I will understand the rules of the game and play within them.
13. I will be gracious in victory and dignified in defeat.

Parent Code of Conduct:

I recognize and accept my responsibility as a representative of the Corunna Wildcats Soccer Club and my child's team and pledge to follow this Parent's Code of Conduct:

1. I will NOT be a sideline coach or referee. I will limit my comments to positive reinforcement and encouragement to my child and his/her teammates.
2. I will lead by example in exhibiting sportsmanship and fair play at every training session, competition and tournament. I will encourage this behavior from other coaches, players, officials and parents and supporters.
3. I will place the emotional and physical well-being of my child ahead of a personal desire to win. Winning should be the result of preparation, hard work and discipline.
4. If my child develops a behavior-related problem that repeatedly disrupts practices and/or games, I promise to work with my child's coach to resolve that problem.

5. I will not sit or stand on the coaches' and players' sideline during a match, unless invited by the coach.
6. I will demand a soccer environment for my child that is free of drugs, including tobacco and alcohol, and will refrain from their use at all practices and games.
7. I will do my very best to make soccer fun for my child and his/her teammates.
8. I promise to treat other fans, coaches, players, and officials with respect, regardless of race, sex, or ability.
9. I will treat teammates, opponents, coaches, officials and fans with respect regardless of race, sex, or ability, and I will expect to be treated the same in return.
10. I will not engage in physical or verbal confrontations with players, coaches, officials or fans before, during or after training sessions and competitions.
11. I will refrain from the use of foul or offensive language.
12. I will provide encouragement to my child and his/her teammates. I will refrain from making negative comments to my child or his/her teammates.
13. I will support the coaches and officials working with my son in order to encourage a positive and enjoyable experience for all.
14. I will be gracious in victory and dignified in defeat.
15. I will remember that the game is for my child and their teammates, not for adults.
16. I will remember that as a fan, I represent the Corunna Wildcats Soccer Club. I understand that any concerns about officiating and/or coaching during a game must be directed to the team manager. I also understand that poor behavior during practices, games or tournaments may result in expulsion from the soccer field, where I must wait inside or next to my car in the parking area for my child. If this occurs, it may result in expulsion from the club.
